

Deerfield, Oct. 5th, 1792—

To the Hon. Eleazar Porter Judge of Probate for the County of Hampshire—

In obedience to a Warrant to us directed, we the Subscribers have made the following distribution of the Real Estate of Mr. John Hinsdale late of Deerfield deceased being the whole of the Estate whereof Said Hinsdale died seized after the Widow's Dower was deducted and the Debts discharged as shewn us by the Administrator. Viz. To Elisha Hinsdale one tract of Land lying on the long Hill East division (so called) being part of Lot No. 1 2 & 3 in Said Division containing twenty five acres and two rods bounded East on Connecticut River South on lands lately owned by Ebenr. Smead decd Westerly on Pine Nook Road North on a Gore of Land Easterly on the top of the East Mountain South on the remaining part of said Lot Westerly on Dean. Asahel Wrights Land being two rods 23 links and 71/100 of a link in width. Also, one other tract of Land containing twenty three acres & thirty five perches. Bounded East on a County Road leading from Wapping to Sunderland in part and in part on Deacn. Asahel Wrights Land. South partly on Deacn.
